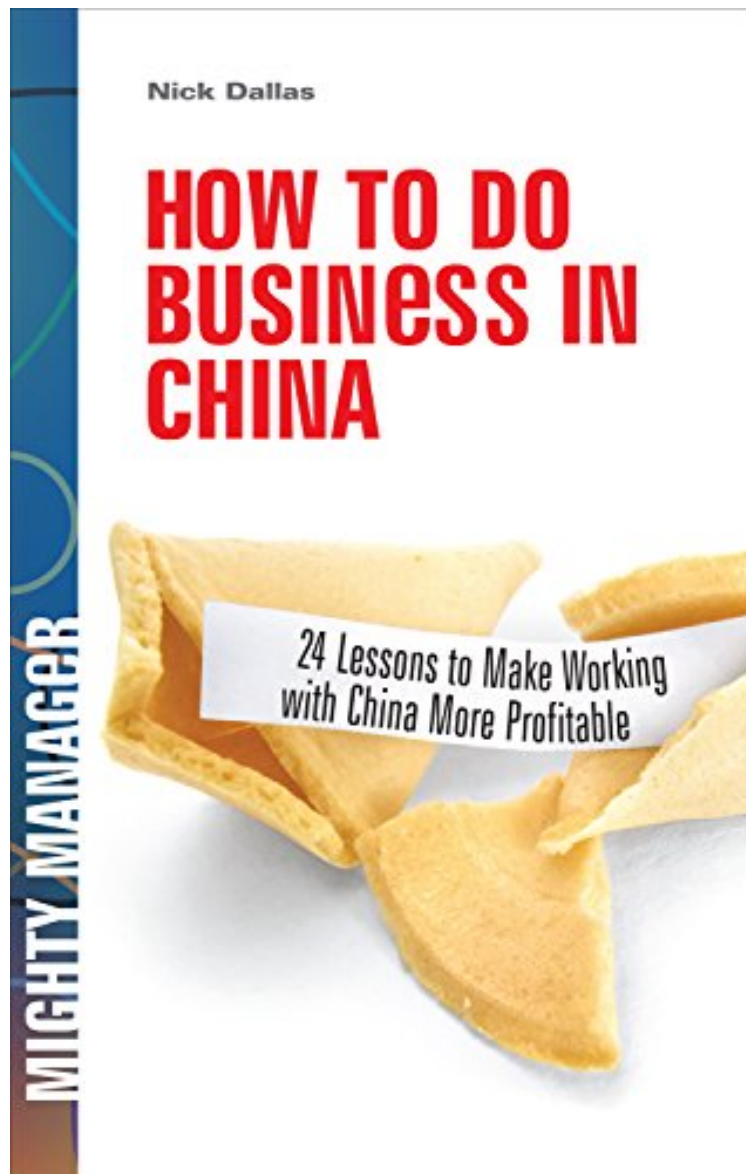

While the ideas the author proposes are interesting: Not trusting any quick solutions, importance of further learning, etc.. All very good, but the author's ideas on them are very brief and lack all details. So for example, he would say that It is important to learn more about China's history, politics, etc.. But he would omit all details of how to approach this, what specifics, and really why? Where has this made a difference, is it always the case? The author raises a lot of good points, but spends little time explaining and lacks giving any good details.
